### Notes on Nomination

1. This Notes on Nomination and the Nomination Forms in English are translated based on the Chinese version. For details of the Applied Learning (ApL) Scholarship (2017/18 School Year), including the nomination criteria and related information, please refer to the Chinese version of the document. The Chinese version shall prevail should there be any inconsistency.
2. Schools should use "Form H" for their nominations. Course Providers (CPs) should use "Form G" for their nominations. "Form H" and "Form G" differ only in Part I. Part II and Part III of the two forms are the same.
3. Part I of "Form H" and "Form G" should be completed by the school and CP respectively.
4. Part II of the form should be completed by the nominators (either school or CP).
5. Part III should be completed by the student nominees. Apart from the ApL Scholarship, all nominees will automatically enter for the nomination of "Special Awards". The purpose of the "Special Awards" is to promote sharing of students' learning experiences and stories, and the awards will be presented to those students with inspiring sharing.

  - by schools: 14 September 2018 (Friday)
